RULES AND REGULATIONS

1. The rental period of this golf cart corresponds to the rental period of the home at 1790 Egret.
2. All cart operators MUST have a valid driver's license, be at least 18 (eighteen) years of age, and have proof of insurance. You must not drive while intoxicated.
3. Golf carts are subject to the same laws and regulations pertaining to motor vehicles and the golf cart must be operated in accordance with the laws of the State of South Carolina and the local laws of Horry County. Although not required, it is advisable to use hand signals when turning or stopping.
4. Recommended safe limit of 6 persons, regardless of age, on golf cart at any one time.
5. The golf cart must remain within Oceanside Village or the Beach parking area. Please park the golf cart in our back yard at night.
6. It is illegal to drive the golf cart at night without lights.
7. Please take the key out of the golf cart when not in use to avoid possible theft of golf cart. There will be a \$25 charge for a lost key.
8. Parking Violations. Park in designated areas only. You are liable for payment of any and all parking violation fines incurred during the term of the rental. If you fail to pay parking tickets incurred during the rental, we have the right to furnish your name and address to the appropriate division or jurisdiction.
9. This is an electric golf cart, which requires periodic charging. The charger is located in the golf cart garage — do not remove the charger from our property or leave outside (heavy dew or rain may damage it). Be sure the cart has a good charge before leaving for an extended ride (arrow pointing to the white bar on right is full charge). An overnight charge should last several days of normal use. Charger is "automatic" and will shut off automatically when cart is fully charged. Large gray end of charger plugs into cart at the driver's side of the cart just below the operator and will only fit one way. ALWAYS unplug the charger before moving the cart.
10. Note that the cart has forward, reverse and neutral gears (operated by lever in front of seat). The brake can be locked in place by pressing the lock at the top corner of the brake pedal.
11. In the event a problem arises we ask that you first check to ensure that all operating instructions are being followed and the cart has been properly charged (the charger indicates when it is connected properly and is charging). Do not attempt to perform repairs on cart. If you are unable to resolve the problem, contact us immediately and we will send out a mechanic. Should the problem result in the loss of use during the rental time, you will be refunded appropriately from the time we are notified. In the event we request a service call and it is determined that the problem is the result of improper operation of the cart or failure to properly connect the charging system, the cost of the service call will be charged against your deposit.

GENERAL TERMS OF USAGE

In consideration of the rental of this golf cart, I agree to:

1. Abide by the RULES AND INSTRUCTIONS on other side.
2. Leave the cart in as good a condition as I received it.
3. Reimburse the owner for or pay for any damages sustained to the cart during this rental period.
4. Defend, indemnify and hold the owner & his/her agent(s) harmless from and against all claims, suits and liabilities, without limiting the generality of the foregoing, for any and all damages to property or person, including, but not limited to injury, death, or damage to any property whatsoever, caused by, arising from, incident to, connected with, growing out of, or related to the use and/or operation of this golf cart during this rental period.

FURTHERMORE, I REPRESENT THAT I AM FAMILIAR WITH THE OPERATION AND USE OF SUCH GOLF CART, THAT I HAVE READ THE RULES AND INSTRUCTIONS CONTAINED HEREIN, AND THAT I AM CAPABLE OF OPERATING THE GOLF CART SAFELY AND IN ACCORDANCE WITH SAID RULES AND INSTRUCTIONS.

5. I agree the privilege of using the golf cart can be revoked without notice for any violation of this agreement. I further agree I shall not be entitled any rental refund or deposit for such revocation of privilege.
6. I understand that if the golf cart should become inoperable through no fault of my own, Glenn and Harriet Oster will take reasonable steps to have the vehicle repaired. In the event the golf cart cannot be repaired or replaced, a refund will be issued towards the unused rental agreement period.
7. I understand that I am responsible/liable for any person in my group using this golf cart and to ensure they understand/follow these rules.

By my signature below, I certify that I understand and agree to the conditions set forth in this Binding Golf Cart Agreement. I acknowledge that I have signed this document voluntarily and freely and that my signature creates a contractual obligation that binds me, my guests and all passengers.
